Student Loans and Allowances

If you are applying for a student loan or allowance (fulltime students only) it is imperative that you contact Studylink (0800 88 99 00) as early as possible to ensure adequate time for processing. Studylink now handles all administration for loans/allowances directly with the student. Apart from the above documentation you will also need proof of your IRD number and a bank deposit slip. Student Loans cover the cost of course fees only and an additional amount is available for course related costs.

Privacy
